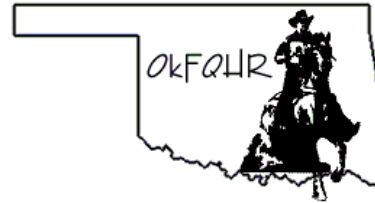

Outside sired foals are nom. Fee of \$400.
